REPORT ON THE ONE-DAY AWARENESS PROGRAMME ON "GIVING OR TAKING OF DOWRY IS AN OFFENCE BY LAW"

The Women Studies Centre, Government College of Education (IASE), M A Road Srinagar, organized a One-Day Awareness Programme on the theme "Giving or Taking of Dowry is an Offence by Law" on **11 July 2026** in the College Auditorium. The programme was envisioned as a significant academic and social intervention aimed at fostering legal awareness, promoting gender equity, and encouraging critical engagement with one of the most persistent social evils affecting contemporary society.

The programme commenced with a warm welcome by **Prof. (Dr.) Seema Naz, Principal/Nodal Principal, Kashmir Division Colleges**, who set the intellectual tone for the event through her inaugural address. She underscored the transformative role of educational institutions in nurturing informed, ethically conscious, and socially responsible citizens. Stressing that the practice of dowry is not merely a legal offence but a profound violation of human dignity and gender justice, she urged students to become catalysts for social change by rejecting discriminatory customs and upholding the constitutional ideals of equality and justice.

The keynote address was delivered by Advocate **Mir Naveed Gul, a distinguished legal practitioner**, who provided an insightful exposition of the legal framework governing dowry-related offences in India. Drawing upon the provisions of the Dowry Prohibition Act, 1961, and other relevant statutory safeguards, he elucidated the legal consequences of giving, taking, or demanding dowry, while highlighting the rights and protections available to women. Through contemporary case illustrations and practical examples, he emphasized the importance of legal literacy, timely recourse to justice, and collective social responsibility in addressing dowry-related violence and discrimination.

The session evolved into an engaging and intellectually stimulating interaction, with students and faculty members actively participating in discussions on the socio-cultural, ethical, and legal dimensions of the dowry system. The deliberations encouraged participants to critically examine the historical roots of the practice, its adverse implications for gender relations, and the imperative of fostering attitudinal change through education, awareness, and community engagement.

The programme concluded with a formal Vote of Thanks presented by **Dr. Tawheeda Rasool, Programme Coordinator**, who expressed heartfelt appreciation to the Principal for her visionary leadership, the resource person for his enlightening deliberation, and the faculty members, organizing

committee, and students for their enthusiastic participation and cooperation in ensuring the success of the event.
